

Board Resolution No. 16 Series of 2020 APPROVAL OF THE SUPPLEMENTARY WORK PACKAGES FOR KMBA MEMBERS' CENTER BUILDING

Upon motion, duly seconded, the Board of Trustees, in a meeting held on March 13, 2020, where a quorum is present, adopted the following resolution:

WHEREAS, in line with the completion of KMBA Members' Center Building, Arch. Eric Vincent Yusingco evaluated supplementary work packages that are necessary to optimize and meet the needs of the building and the potential lessees of the building;
