

## Board Resolution No. 38 Series of 2020

## **REALIGNMENT OF FREE AND UNASSIGNED SURPLUS**

Upon motion, duly seconded, the Board of Trustees, in a Regular Board Meeting held on December 10, 2020, where a quorum is present, adopted the following resolution:

**WHEREAS,** KMBA has completed the assessment of its operations and financial position as of October 2020;

WHEREAS, based on the prior allocation approved for the years 2020-2021 of Fourteen Million Five Hundred Forty-Four Thousand One Hundred Ninety-Seven & 47/100 (Php 14,544,197.47) Pesos, a total of Three Million Eleven Thousand Nine Hundred Thirty-Two & 50/100 (Php 3,011,932.50) were actually expended and used at current year as follows;

WHEREAS, to make effect the increase in the abovementioned items, a remote to no activity for the enhancement of equity value was projected, thus zeroing the percentage of allocation for the said item;

**NOW THEREFORE,** the foregoing premises considered, the Board of Trustees **RESOLVED** to approve the realignment of free and unassigned surplus amounting to Eleven Million Five Hundred Thirty-Two Thousand Two Hundred Sixty-Four & 97/100 (Php 11,532,264.97) Pesos.
