## **RELATED PARTY TRANSACTION COMMITTEE**

The Related Party Transaction Committee is established to enhance the organizations transparency and promote fair transaction.

In accordance with the Insurance Commission's recommendation, Related Party Transaction Committee is composed of at least Three (3) Non-Executive Director, elected by the general membership during Annual General Meeting of whom majority is Independent Trustee including the chairman.

The Related Party Transaction Committee is Responsible for reviewing all material related party transactions of the company. The RPT Committee shall work closely to the Audit Committee for the review and approval of any material or significant RPTs or conflict of interest issues involving members of the Board and Management Team to ensure that these are conducted or resolved in the best interest of KMBA and its members.

### **Authority:**

The Related Party Transactions Committee shall have the authority to:

- Receive reports on transaction between KMBA and its affiliates or partner organization;
- Order an investigation on documents of related party transactions;
- Recommends to the Board of Trustees to take corrective measures to those that violate company regulations

### **Roles and Responsibility:**

- Investigate and report to the board of trustee on finding any related party transaction
- Prepare action plan and corrective measures for board approval
- Ensure that handling of conflict of interest on RPT's are conducted in the best interest of KMBA and its members
