

Board Resolution No. 32 Series of 2021

APPROVING THE REALIGNMENT OF THE EXCESS UNASSIGNED SURPLUS 2022-2024

Upon motion, duly seconded, the Board of Trustees, in a Regular Board Meeting held on October 29, 2021, where a quorum is present, adopted the following resolution:

WHEREAS, upon determination of the expended fund from the allocation of excess unassigned surplus for the year 2021, a remaining balance amounting to Ten Million Nine Hundred Ninety Thousand Three Hundred and Thirty-Eight & 59/100 (Php 10,990,338.59) Pesos was identified;

WHEREAS, the Management places to the Board its proposed realignment of the allocation mix of the balance of free and excess unassigned surplus to best reflect and ensure that organizational needs for the years 2022-2024 will be met;
